

MANAGERS - WORKPLACE OCCUPATIONAL HEALTH AND SAFETY POLICY

Intent

It is the responsibility of The Authentic T-Shirt Company*/SanMar Canada (the Company) to provide a safe and healthy work environment for all employees, customers, visitors and contractors. The Company will develop, operate and maintain policies and procedures that align in accordance with Occupational Health and Safety standards. The Company outlines respective roles and responsibilities in this policy. This policy is to be used in conjunction with the Employee Occupational Health and Safety Program.

The Occupational Health and Safety Policy is committed to providing workers with a safe and healthy workplace by:

- Promoting a positive attitude towards health and safety in the workplace
- Providing sufficient resources to implement the Occupational Health and Safety Program
- Cooperating with the Joint Health and Safety Committee (JHSC) to identify hazards, assess risks and establish controls to eliminate or reduce risk of injury or illness

The Company will act in compliance with all Local, Federal, and Provincial workplace health and safety legislation and establish safe work procedures.

Employees are defined as: Full time, Part time, Coop students, Casual, Seasonal, Temporary labourers/workers

Responsibilities

- It is the responsibility of The Authentic T-Shirt Company®/SanMar Canada's management to develop, implement and
 maintain programs designed to prevent injuries and occupational diseases throughout The Company's workplaces by
 ensuring that health and safety hazards are controlled or eliminated, and by developing work procedures conducive
 to a healthy and safe workplace.
- It is the responsibility of every supervisor to ensure that all workers are instructed in, and follow all safe work procedures and regulatory requirements.
- It is the responsibility of all workers to follow proper safe work procedures and to monitor their workplaces for unsafe conditions and hazards.
- It is the responsibility of all contractors working for or on behalf of The Authentic T-Shirt Company®/SanMar Canada to implement effective safety programs for their workers, and comply with all safety rules of The Authentic T-Shirt Company®/SanMar Canada.
