

# **Tuition Assistance Program**

As part of our commitment to support the continuing growth of our team members, The Authentic T-Shirt Company<sup>®</sup>/SanMar Canada (the Company) recognizes that ongoing learning is important to fostering an engaged workplace. The Authentic T-Shirt Company<sup>®</sup>/SanMar Canada may provide some financial assistance for courses employees wish to take on their own time when a strong business case can be made.

### Am I Eligible?

To be eligible for assistance, employees must have completed one (1) continuous year of permanent full-time employment.

### What Courses Are Covered?

In order for a course(s) to be approved, they must satisfy the following conditions:

- The Authentic T-Shirt Company<sup>®</sup>/SanMar Canada has no immediate plans to offer training internally.
- The institution offering the course(s) must be a recognized university, community college, or technical, vocational, or correspondence school with an accredited curriculum in the appropriate field.
- The course(s) must not interfere with an employee's work on Company time. Employees are expected to attend classes, do assignments and preparation on their off hours.

### Sponsorship

All courses, including those part of an overall program must be pre-approved by your department manager and senior management. The Authentic T-Shirt Company®/ SanMar Canada will reimburse 100% of course fees and textbooks up to a maximum of \$1500.00 or two (2) courses per calendar year.

To qualify for tuition assistance, the employee must achieve a grade of B- or higher. Assistance is conditional on the employee's continued full-time regular employment for a period of twelve (12) months after the successful completion of the approved course(s). If the employee voluntarily terminates their employment, the employee is required to repay The Authentic T-Shirt Company®/SanMar Canada for all monies associated with tuition assistance through payroll deductions.



#### **Employee Agreement**

While education assistance is expected to enhance employee performance and professional abilities, The Authentic T-Shirt Company<sup>®</sup>/SanMar Canada cannot guarantee that participation in formal education will entitle the employee to automatic advancement, a different job assignment or pay increase.
